### Data protection information according to Art. 13 and 21 DSGVO

Data protection is of particular concern to us. We process your personal data (hereinafter "data") in accordance with the legal requirements and would like to do so in a transparent manner. Therefore, with the following data protection information, we would like to briefly explain to you what data we process, and for what purposes and on what legal basis this is done. In addition, you will receive information about contact persons as well as your rights in connection with data processing.

#### Purposes and legal basis of data processing:

- 1) We use your full name, gender, email address and phone number to register for the Summer School. This serves the purpose of carrying out the registration as well as on-site coordination and is thus in our legitimate interest. The data will be processed by members of the junior research group and partners of the event. The legal basis for this processing is Art. 6 para. 1 p. 1 letter f DSGVO.
- 2) During the Summer School, photographs and video recordings will be taken, which may also include participants. We use these in the legitimate interest of making the results of the event available to participants and the public. The legal basis for this processing is also Art. 6 para. 1 p. 1 letter f DSGVO.

#### General Information:

Even if you do not make use of your rights below, your data will only be stored by us for as long as it is necessary for the above-mentioned purposes. This does not apply if, in derogation thereof, a longer storage or retention period is required by law or is necessary for legal enforcement within the statutory limitation periods. If data is only retained for the aforementioned purposes, data access is limited to the extent necessary for this purpose.

As a matter of principle, we keep your data to ourselves and make it available only to those employees who need it for their work within the scope of fulfilling their tasks. This does not apply if we are legally obligated to disclose it. In addition, we pass on the data to our event partners in accordance with the above-mentioned purposes, insofar as the partners require it for the organization of their sessions. The data processing is carried out in accordance with the legal requirements; the protection of your rights is guaranteed.

Automated decision-making including profiling as defined in Art. 22 (1) and (4) DSGVO does not take place.

#### Your right to object according to Art. 21 DSGVO:

You have the right to object to the processing of personal data concerning you at any time on grounds relating to your particular situation. In this case, we will no longer process this data unless we can demonstrate compelling legitimate grounds for the processing that override your interests, rights and freedoms, or the processing serves to assert, exercise or defend legal claims.

#### Your other rights:

You have the right to request information from us about the processing of data concerning you. In addition to a copy of the data, this right to information also includes the purposes of the data processing, the data recipients and the storage period.

If incorrect data is processed, you may request us to correct this data without delay. If the legal requirements according to Art. 17 or 18 DSGVO exist, you are also generally entitled to the right to immediate deletion or restriction of the processing of the data. Please note that restricted processing of the data may not be possible. Furthermore, you may exercise your right to data portability under the conditions of Art. 20 DSGVO.
